The regular meeting of the Midway City Council was called to order by Mayor Grayson Vandegrift and the following Council Members were present: Steven Craig, Dan Roller, Sara Hicks, Bruce Southworth, Libby Warfield and Kaye Nita Gallagher. Also present was City Attorney Phil Moloney.

Motion by Council Member Dan Roller and seconded by Council Member Sara Hicks to approve the May 18, 2015 regular meeting minutes. Motion carried 6 to 0.

Council Member Bruce Southworth requested and City Attorney Phil Moloney gave the second reading of Ordinance 2015-03 Budget and Appropriations.

Motion by Council Member Sara Hicks and seconded by Council Member Bruce Southworth to adopt Ordinance 2015-003 Budget and Appropriations. Motion carried 6 to 0.

Steve Mims, President of Advancing Sustainable Aquaculture Performance LLC, spoke to the council about getting the fish project in operation again at the old sewer treatment plant. He wants to engage in a three year contract with the city to grow large mouth bass.

Council Member Dan Roller requesting and City Attorney Phil Moloney read Ordinance 2015-002 City of Midway, Kentucky Establishing a New Chapter In The City of Midway Code of Ordinances Titled "Housing, Public Accommodations and Employment" Prohibiting Discrimination Against Individuals on The Basis of Race, Color, Religion, National Origin, Sex, Age, Familial Status, Disability, Gender Identity and Sexual Orientation And Creating An Administrative Enforcement Procedure And Repealing City of Midway "Fair Housing And Discrimination" Ordinance 94.01 to 94.13 and 94.99.

There was little discussion among the council members concerning the “fairness ordinance”, however Council Member Libby Warfield read a statement that she had prepared. (see attached copy)

Motion by Council Member Sara Hicks and seconded by Council Member Kaye Nita Gallagher to adopt Ordinance 2015-002 City of Midway, Kentucky Establishing a New Chapter In The City of Midway Code of Ordinances Titled “Housing, Public Accommodations and Employment” Prohibiting Discrimination Against Individuals on The Basis of Race, Color, Religion, National Origin, Sex, Age, Familial Status, Disability, Gender Identity and Sexual Orientation And Creating An Administrative Enforcement Procedure And Repealing City of Midway “Fair Housing And Discrimination” Ordinance 94.01 to 94.13 and 94.99. Motion carried 4 to 2.

Motion by Council Member Sara Hicks and seconded by Council Member Bruce Southworth to apply for Midway Sanitary Sewer Evaluation and Improvements through KIA. CWSRF 2016 FY Loan Invitation (KIA-A16-034) Motion carried 6 to 0.

Motion by Council Member Steve Craig and seconded by Council Member Kaye Nita Gallagher to adjourn (6:15 pm) Motion carried 6 to 0.
